



OMA announces approval of Master Development Program for the 2021-2025 period

Mexico City, Mexico, November 30, 2020—Mexican airport operator Grupo Aeroportuario del Centro Norte, S.A.B. de C.V., known as OMA (NASDAQ: OMAB; BMV: OMA), announced that it received approval from the Ministry of Communications and Transportations, through the Federal Civil Aviation Agency, of the Master Development Program for each of its thirteen airports, corresponding to the 2021-2025 period.
