OMA reports a 61.3% decrease in August 2020 passenger traffic

Mexico City, Mexico, September 4, 2020—Mexican airport operator Grupo Aeroportuario del Centro Norte, S.A.B. de C.V., known as OMA (NASDAQ: OMAB; BMV: OMA), reports that terminal passenger traffic at its 13 airports decreased 61.3% in August 2020, as compared to August 2019. Domestic traffic decreased 59.4%, and international traffic decreased 77.4%.
