



OMA reports a 50.7% decrease in September 2020 passenger traffic

Mexico City, Mexico, October 5, 2020—Mexican airport operator Grupo Aeroportuario del Centro Norte, S.A.B. de C.V., known as OMA (NASDAQ: OMAB; BMV: OMA), reports that terminal passenger traffic at its 13 airports decreased 50.7% in September 2020, as compared to September 2019. Domestic traffic decreased 48.9%, and international traffic decreased 65.9%.
