OMA reports 1.94 million passenger traffic in July 2021

Mexico City, Mexico, August 4, 2021—Mexican airport operator Grupo Aeroportuario del Centro Norte, S.A.B. de C.V., known as OMA (NASDAQ: OMAB; BMV: OMA), reports that terminal passenger traffic at its 13 airports increased 215.6% in July 2021, as compared to July 2020. Domestic traffic increased 196.1%, and international traffic increased 490.6%. It is important to mention that the base of comparison of July 2020 was still affected by the restriction of activities in Mexico.
