OMA reports 1.55 million passenger traffic in May 2021

Mexico City, Mexico, June 4, 2021—Mexican airport operator Grupo Aeroportuario del Centro Norte, S.A.B. de C.V., known as OMA (NASDAQ: OMAB; BMV: OMA), reports that terminal passenger traffic at its 13 airports increased 1,080.4% in May 2021, as compared to May 2020. Domestic traffic increased 962.3%, and international traffic increased 3,099.3%. It is important to mention that the base of comparison is affected by the suspension of non-essential activities in Mexico during May 2020.
